## **301/24 PUBLIC PARTICIPATION:**

Town Councillor Rees spoke about the proposals to be considered by members in agenda item 7, War Memorial. He reported that the absence of lighting at the War Memorial was first brought to the attention of the Events Working Party and that a brief investigation was carried out in response to this. It was discovered that there was no source of electricity to the memorial and that further investigation should be carried out to see whether an electric feeder pillar could be installed to create a source of electricity with the view to restore its lighting. He also informed members that the War Memorial could do with a deep clean as well as a regular schedule of general cleans going forward.
